### The SD70M

The second new model from General Motors Locomotive Group is the SD70M.

The first two prototype demonstrators (7000 and 7001) were shipped from the London plant in July, a third was to follow in August.

The SD70M was first announced in mid-1991 and except for the radial trucks is virtually identical in appearance to the SD60, from which it was developed. It is still a DC traction motor locomotive, perhaps the last DC model, with production AC units expected in the not too distant future.

### **SCANNER LAWS**

Carrying a scanner either in your car or outside your

home is illegal in some states and municipalities.

These locations are:

- 1. New Jersey
- 2. Kentucky (mobile only)
- 3. Indiana (mobile and outside home)
- 4. Florida (mobile)
- 5. Minnesota (mobile)
- 6. New York (mobile)
- 7. Michigan (mobile)
- 8. Chattanooga, TN (mobile)

Being a licensed amateur radio operator with at least a Technician class license will exempt you from these laws in all but Kentucky and New Jersey. Novice license will suffice in lieu of a Technician class, except in Michigan, where the Technician is required.

It is relative easy to obtain the new No-Code Technician class license. All that needs to be done is to study the booklet and pass a multiple choice, 55 question test in front of a Volunteer Examining Committee (VEC). The cost for the test is normally \$5.25. Size of Rail Necessary to Carry a Given

Load. — The following formulas may be employed for determining the size of rail and wheel suitable for carrying a given load. Let A = the width of the head of the rail in inches; B = the diameter of the wheel in inches.

Then the width of the tread of the rail in inches is found from the formula:

> B=C/1250D (1) The head equals B+ 5/8 inch. The Diameter D of the smallest wheel that will safely carry the load is found from the formula:

D = C/AxK (2) In which K = 600 to

800 for steel Castings; K = 300 to 400 for cast iron.

As an example, assume that the wheel-load in a given case is 10,000 pounds: the diameter of the wheel is 20 inches; and the material steel casting. Determine the size of rail necessary to carry this load. From Formula (1): B = 10,000 / 1250x20 = 0.4 inch

Hence the width of the rail required equals 0.4b+5/8 inch = 1.025 inch. Determine also whether a wheel 20 inches in diameter is large enough to carry the load. From Formula (2):  $D = 10,000 / 1.025 \times 600 = 16.25$  inches.

From the table we see that an HO model of a freight train traveling at a scale speed of 45 MPH should take 13.3 seconds to travel ten feet or almost a whole minute to travel forty feet. Most of us run our trains way too fast

And it is amazing how much more realistic the operation is when the speeds are reduced to their scale equivalent. Remember that very few of us consistently observe the operation of a prototype train from a distance that is equivalent to our normal viewing distance for the model. An HO mode viewed from a distance of three and one-half feet is equivalent to viewing the prototype from the length of a football field. Take a look at the prototype from that distance some time instead of from trackside. Note the difference.

Some of you N scale people will be shocked to note that an N scale train traveling at a scale speed of five MPH will take 218 seconds or more than three and one-half minutes to travel ten feet. Now check back and you will find that ten feet is equal to 1600 scale feet or about three/tenths of a mile in N is only thirty-three feet.

#### **MORE MODELING TIPS & IDEAS**

When installing KADEE couplers, file the front inside edge of the coupler POCKETS AND THE BRASS SPRING front edge to remove any burrs.

Most problems of hanging up comes from these two points. Check after assembly but before lubing for any hang ups. If they don't move before lubing for any hang ups. If they don't move before lubing, they won't move after. Don't forget to lube!

When installing truck assemblies on rolling stock, install one end so it will turn freely but not rock from side to side. Install the second truck so it will turn freely and have a slight rocking from side to side. This will allow for a three pint or tripod effect and stop a car from wobbling down the track.

Spray painting some of those water based paints. Try using a denatured alcohol as thinner. This will cause it to adhere better and dry faster. Caution. Not all will mix. So try first. In a spray gun, airbrush, be ready to clean up fast because it dries fast in the gun also.
